

# Maras wins top business awards

ADELAIDE-based property developer Maras Group has taken out seven awards at the annual International Business Awards.

Nicknamed the Stevies from the Greek word for crowned, gold, silver and bronze awards were handed out to organisations and individuals from more than 40 nations and 3300 nominations.

Maras won four gold prizes, ranking the company as the second most successful winner in this year's awards. Just eight gold awards went to Australian businesses.

Maras took out gold awards for most innovative company in Asia, Australia and New Zealand and real estate company of the year.

Managing director Steve Maras was personally honoured with a Gold Stevie for real estate executive of the year and maverick of the year for his work promoting the mainstream industry.

"To have our organisation acknowledged internationally for the work we have done in South Australia is tremendously rewarding and humbling," Mr Maras said.
